Jump Height Order

Obedience and Rally classes will be run short-to-tall on Friday, tall-to-short on Saturday and short-to-tall on Sunday. Exhibitors entering classes with jumps are required to include their dog's jump height on the entry form. Tall to short will be accomplished with reverse catalog order for all classes.

Every effort will be made to accommodate handlers with multiple dogs in the same class.

Judges for run-offs will be determined the day of the trial.
