- Open Intermediate For boys and girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.
- Open Senior For boys and girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.
- Master For boys and girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) first place wins in an Open Class, with competition to be eligible to enter the Limited Class Competition. Dogs Eligible to Enter

These shows are open to Shetland Sheepdogs which have been registered with the American Kennel Club and are six (6) months of age or older or have an acceptable foreign registration number (subject to restrictions in Chapter 11, Section 1 of the Rules Applying to Dog Shows).

The Obedience and Rally trials are open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds. Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes. .

Transfer Information

Moveups/Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial. Email notice is acceptable.


