Jump Height Order

On Saturday all Obedience classes with jumps will be run short-to-tall.

On Sunday all Obedience classes with jumps will be run tall-to-short. To accomplish this, all classes on Sunday will be run in reverse catalog order, with each class starting with the highest armband number and running backwards.

Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

Trial Information

The building will be available at 2:00 pm on Friday for set-up and the OC Match.

Crating space is limited. Please restrict your crate space to the minimum required for your dogs.

There will be no crating space available for unentered dogs.

Food on Site

A limited number of lunches will be available for \$5 – main dish, side, drink and dessert – provided by Second Chance Sheltie Rescue.

Notice to Exhibitors

SHOW SITE will be available from 2:00 PM to 7:00 PM on Friday, 7:00 AM to 8:00 PM on Saturday and 7:00 AM to show close on Sunday.

OVERNIGHT PARKING will be permitted in the parking lot Friday and Saturday night, but no hook-ups or facilities are available.

NORTH ST. LOUIS COUNTY OTC, its members and Westinn Kennels assume no responsibility for loss, theft, damage or injury sustained by an exhibitor, handler, or any of their dogs or property and further assume no responsibility for injury to children.

EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

NO ENTRY FEE WILL BE REFUNDED in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.

NO ENTRY FEE WILL BE REFUNDED if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause which is beyond the control of the Club or the Trial Secretary.

BITCHES COMING INTO SEASON after close will receive a refund of their entry fee less \$8.00 per day entered provided the trial secretary is notified prior to the start of the trial and written verification is provided by a veterinarian.

DOGS MUST BE READY FOR JUDGING WHEN CALLED TO THE RING. Neither the club nor any ring steward will be obliged to call or notify exhibitors of when they are due in the ring for judging. Judges are not required to wait for any dog.

ALL CELL PHONES must be turned OFF when in the show building except the emergency cell phone located at the secretary's table, 314-954-5951.

NCOTC reserves the right to substitute prizes of equal or greater value.

TRANSFERS will be allowed per AKC regulations, provided that a written or email request is made to the Trial Secretary at least one-half hour prior to the start of the trial.

NCOTC DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

Routes to the Trial

FROM THE WEST: I-70 east to Exit 208. Turn right at end of ramp, then immediately right again onto the South Service Road. Turn left on Swantnerville Dr (0.5 mi). Westinn Kennel is 500 feet down on the left.

FROM THE EAST: I-70 west to Exit 208. Turn left at end of ramp. At the end of the overpass, turn right onto the South Service Road. Turn left on Swantnerville Dr (0.5 mi). Westinn Kennel is 500 feet down on the left.



OC Matches

Friday

Match will run from 2:00 pm to 7:00 pm.

First come — first served.

Come set up your crates and get ready for the weekend.

Saturday

Match will start 30 minutes after the completion of the trial.

Sign up starts at 9:00 am Saturday.

Due to time constraints there will be a limit of 24 entries per ring.

One entry per dog per ring will be allowed until the limit of 24 is reached.

If the limit is not reached, second entries will be allowed until the limit is reached.

Three rings available — Novice, Open, Utility.

Sits and downs will be scheduled as needed.

Entry fee — \$10.00 for 10 minutes.

Participation is limited to only those dogs entered in our trials.
